SUBJECT: ACCC/JWBWH FORKLIFT RFP – ADDENDUM #1

COMMENT

Refer to attached revised critical dates.

QUESTION:

1. Section 11 (pg. 18) – If Oakview is sued because the RFQ references certain product specification, that the vendor would have to defend and hold Oakview harmless?

2. Section 13 (pg. 18) – given this cancellation provision, is there anything that would prevent or make it very difficult to sell these units to another customer?
NO
3. Page 39 – given this clause, it is critical that we provide a delivery date that can be absolutely counted on. There is no Force Majeure clause in the PO terms. Can a Force Majeure clause be added in case we have another situation like COVID that disrupts supply chains.

4. The bid calls for a 5,500 lb. capacity forklift and we offer either 5,000 or 6,000 lb. capacity models. Will Oakview accept either of these capacities?

5. The specifications call for a Monotrol Pedal with directional control, which we do not offer on our forklifts. Will you accept a directional control attached to the steering column?
NO
6. The bid specifications call for a telemetry tracking system, which is not included as standard equipment on our forklifts. Will Oakview accept the equipment without the system, or could we install the system after it has been delivered?

7. The bid requirements call for delivery within five business days of receiving the order. The equipment we are bidding is in stock at our factory in Buford, Georgia. To receive and process the order, schedule delivery and transport it to New Jersey may take two or three weeks. Is that acceptable?

8. Our forklifts are built in South Korea before being shipped to the US for final prep and delivery. Is the acceptable under the Buy American clause of the bid?
